- The FY 2014 fees were adopted by the Board on May 15, 2013. Subsequent fiscal year fees will reflect changes in the Consumer Price Index. There was a 0.1% decrease in the Consumer Price Index as used for calculating the Title V emissions fee rate applicable to Fiscal Year 2021.
