

2018	New street lights installed on Elliott Avenue. LG&E was replacing lights in various neighborhoods, and LMPD recommended Elliott Avenue as one possible location for investment. Develop Louisville used nearly \$5,600 of its FY17 capital funds for “vandal shields” for the new lights.
