CALL TO ORDER 3:00 PM:

ADOPT MINUTES FROM PREVIOUS MEETING 3:00PM:

- Bill Motioned to adopt the November 30 meeting minutes, Estela Seconded, motion Carried

OLD BUSINESS

UPDATE ON REMAINING FUNDS 3:05 PM:

- Nate Keltch presented on the areas that the CSC asked to investigate at the September CSC Meeting:
 1. Shelby Park – Shelby Park Neighborhood Association
 - Nate presented to SPNA on moving forward with Oak bumpouts but not speed table
 - The Speed table was not possible as Oak is a minor arterial and there would be storm water issues making the project more expensive than we have budget for
 - SPNA said they would enter into an MOA for the project
 - Ken moved to allocated \$65K of the CSC traffic calming fund to the bumpout project, with Janet seconding. Motion carried unanimously
 2. Wheatley Elementary School – California Neighborhood Association
 - Nate received input from the Neighborhood Association
 - PW is exploring options on 17th street
 - Another meeting with the NA is to be scheduled

CHECKLISTS TO BE REVIEWED 3:15 AM:

- Nathan Keltch & James Maynard presented Checklists to the CSC:
 1. Aiken Road and Arnold Palmer Road Roundabout
 - PW provided further details in an updated checklist
 - CSC asked further follow questions about the design
 - Janet motioned to approve, Ken seconded. Motion carried unanimously
 2. SS4A River Road
 - Some issues with Witherspoon be cleared up. Are Witherspoon crosswalk improvements within the scope of review?
 - Also issues with the median size are still to be determined as in the current design there is a problem for emergency services
 - in order to get answers on these items the Checklist needed to be approved in its current state with the idea that the CSC will come back to it when the project is amended
 - Ken motioned to approve this checklist, Anita seconded. Motion passes with 7 “ayes” Bill voting ‘Present’
