General Information

For the purposes of this Questionnaire, "Venture Capital Fund" is defined as: A limited liability company, limited liability partnership, or limited partnership, formed and operated for the exclusive purpose of buying, holding and/or selling securities (including debt securities), on its own behalf and not as a broker, primarily in non-publicly traded companies, and the capital of the fund is primarily derived from investments by entities and/or individuals which are neither, directly or indirectly, related to nor affiliated with the fund. The following provisions shall apply:

(a) **AFFILIATED** Entities that are part of an affiliated group as defined in 26 U.S.C. § 1504(a) and any applicable federal regulations thereto, as they may be amended from time to time;

(b) **NON-PUBLICLY TRADED COMPANIES** Any business entity that is not a **PUBLICLY TRADED COMPANY**, as defined below

(c) **PRIMARILY** as used in this section, means over 80%.

(d) **PUBLICLY TRADED COMPANY** Any entity that is traded on:

- A national securities exchange registered under § 6 of the Securities Exchange Act of 1934 or exempted from registration under such act by 15 U.S.C. § 78f because of the limited volume of transactions
- A foreign securities exchange operating under principles analogous to a national securities exchange
- A regional or local exchange
- An interdealer quotation system that regularly disseminates firm buy or sell quotations by identified brokers or dealers by electronic means or otherwise
- On a secondary market or the substantial equivalent thereof, if taking into account all of the facts and circumstances, the owners are readily able to buy, sell or exchange their ownership interest in a manner that is comparable, economically, to trading on an exchange

(e) **RELATED.** Entities and/or individuals that are related as determined by 26 U.S.C. § 267(b) and (f) and any federal regulations applicable thereto as they may be amended from time to time.
