******SUSPENSION ORDER******

This cause having been brought on for Hearing before the Louisville/Jefferson County Metro Alcoholic Beverage Control Board on Tuesday, September 15, 2015, pursuant to Notice, on a citation wherein the Licensee, Cahoots, Inc., was cited to show cause, if any, why the above referenced license should not be suspended or revoked because of the following:

**LMCO 113.24 (1st Offense)
Revocation or Suspension of License**

The Honorable Pete Karem presided at the Hearing of the Louisville/Jefferson County Metro Alcohol Beverage Control. The Honorable Larry Osterhage, attorney for the Louisville/Jefferson County Metro ABC, represented the interests of the Metro ABC.

The Louisville/Jefferson County Metro Department of Codes & Regulations, Division of Alcohol Beverage Control presented testimony to support the respective positions.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

1. That the Licensee holds the above referenced license(s).
2. That all notices required to be sent or received, have been in a timely manner.
3. That on or about July 21, 2015, the Licensee was cited for the above referenced violation(s).
4. That there is sufficient evidence to support the charge of **LMCO 113.24** and that the Licensee did violate the statute and ordinance as charged.
5. That the Licensee's license be suspended immediately having defaulted on the terms of the previous July 14, 2015 Agreed Order, which required agreed upon security starting on July 21, 2015.
6. That the Licensee's suspension begins Friday, November 27, 2015 through Friday, January 1, 2016, without right of payment in lieu of suspension under KRS 243.480.
7. That all evidence confiscated will be destroyed.

IT IS THEREFORE ORDERED AND ADJUDGED by the Louisville/Jefferson County Metro Department of Codes & Regulations Division of Alcoholic Beverage Control, that the above referenced license(s), issued to Cahoots, Inc., dba/Cahoots, be, and the same hereby are **SUSPENDED** effective Friday, November 27, 2015 through Friday, January 1, 2016. **Retail Licensee must keep all alcohol in a locked compartment kept separate from the service associated with food, or the business must be locked and closed.**

Appeal of this Suspension Order of the Administrator herein shall be filed within thirty (30) days of the date of this order with the Kentucky Alcoholic Beverage Control Board, 1003 Twilight Trail, Frankfort, Ky. 40601, in accordance to KRS 241.200.
