ORDINANCE 13-01

AN ORDINANCE RELATING TO THE SIZE OF MENU BOARD TYPE SIGNS, AND
AMENDING ST. MATTHEWS ORDINANCE 91-12, SECTION D (4) (ARTICLE 11 OF
LAND DEVELOPMENT CODE).

WHEREAS, the City of St. Matthews has received recommendations from the Louisville and
Jefferson County Planning Commission relating to signs; and

WHEREAS, the City is desirous of increasing the size of allowable menu board type signs to that
contained in the said recommendation; now therefore,

BE IT ORDAINED BY THE CITY OF ST. MATTHEWS:

Section 1 Article 11 of the Development Code For The City of St. Matthews, as
adopted by Ordinance 91-12, Section D (4) is hereby deleted and re-enacted to read as follows:


D. Business Signs..

(4) Freestanding Directional Signs. Freestanding directional signs, i.e., signs used
primarily to direct on premise vehicular or pedestrian circulation or traffic, are permitted to a
maximum height of three (3) feet, with a maximum area of five (5) square feet. Such signs shall
not be counted toward the number of freestanding signs allowed on a lot. One single faced "Menu
Board" type sign is allowed for a "drive through" facility and shall not be counted toward the
number of freestanding signs allowed, provided such sign is no larger than Forty square feet, and
limited to one such Menu Board per each drive-thru lane.

Section 2 Except as modified herein, the balance of Ordinance 91-12 shall remain
in full force and effect.

Section 3. This ordinance shall become effective upon its passage and publication
as provided by law.
