## Program Descriptions

**Save The Structure:** This program allows the applicant to purchase a structure by showing proof of funds for the minimum amount required. Applicants must complete exterior and structural repairs within 6 months from the date of sale and the remaining interior repairs within 18 months from the sale.

**Demo For Deed:** This program allows the applicant to purchase a structure by providing an estimate from a licensed demolition contractor and providing proof of funds for the cost of demolition. Applicants must complete demolition of the property within 45 days from the date of sale.
